## CURRENT RESEARCH INTEREST

My current research aims to critically engage with women-led grassroots level legal advocacy mechanisms as models for feminist legal jurisprudence in India. The primary sites of study are para-state and non-state (civil society led) community-level mechanisms variously named *Nari Adalats, Mahila Shalishi, Mahila Jamaat, Mahila Gram Sabha*, etc which together with state-initiated mechanisms like Mahila Samakhya, Family Courts, Women's Cell and Women's Commission initiatives, will be contextualized within the larger trajectory of women's political activism and legal scholarship in India. The women-led community-level legal advocacy mechanisms will be studied as a framework for women's enhanced participation in local governance in terms of addressing gendered practices of violence and harassment, i.e. as an attempt at gendering local governance. The focus will be on feminist strategizing as a tool for the same. The mechanisms will also be problematized as sites which reflect the complex location of women at the intersection of individual rights, human rights and community rights. To that end, the idea of 'community' will be critically engaged with using a critical legal theory framework.
